The program provides opportunities for participants to succeed in their precollege performance and ultimately in their higher education pursuits. In 2012, we established the Upward Bound program at the target schools, recruited and served the required amount of students, hired tutorial staff, provided daily tutorials for students after school, facilitated a six-week intensive summer program, hosted multiple workshops, and organized multiple field trips to colleges and culturally enriching sites.

Upward Bound Math and Science is a federal grant program funded by the Department of Education designed to strengthen the math and science skills of participating students. In 2012, we established the Upward Bound program at the target schools, recruited and served the required amount of students, hired tutorial staff, provided daily tutorials for students after school, facilitated a six-week intensive summer program, hosted multiple workshops, and organized multiple field trips to colleges and STEM intensive sites.

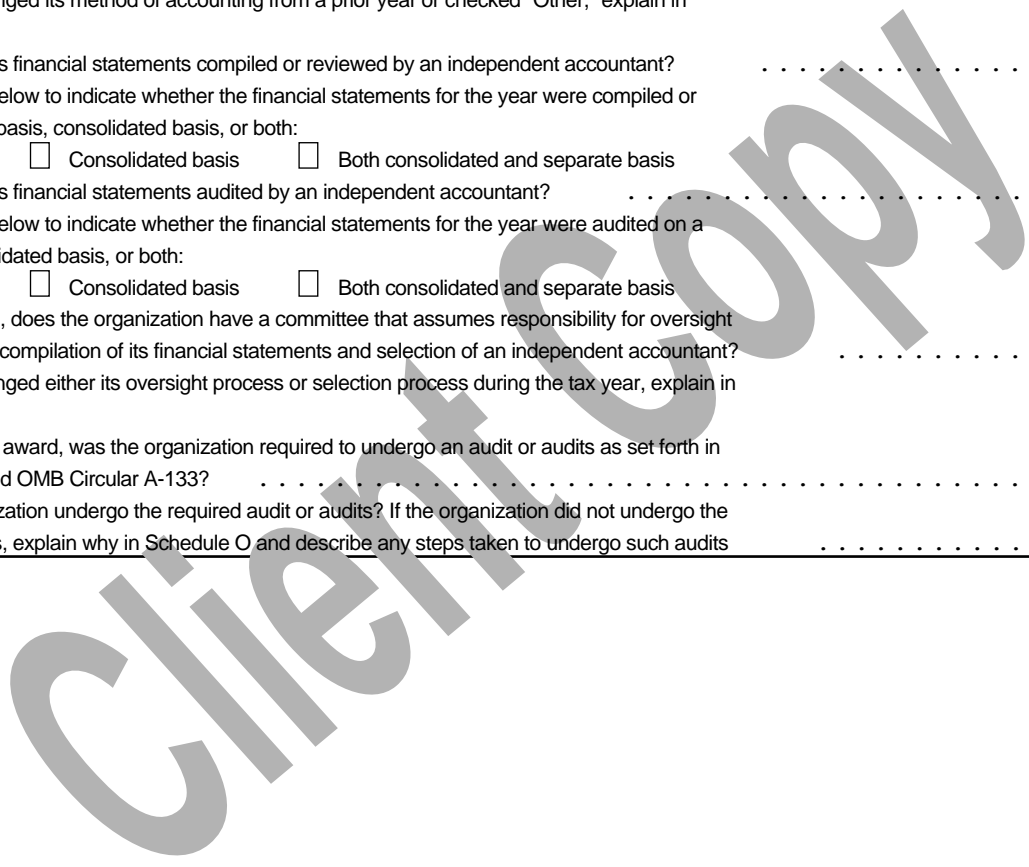

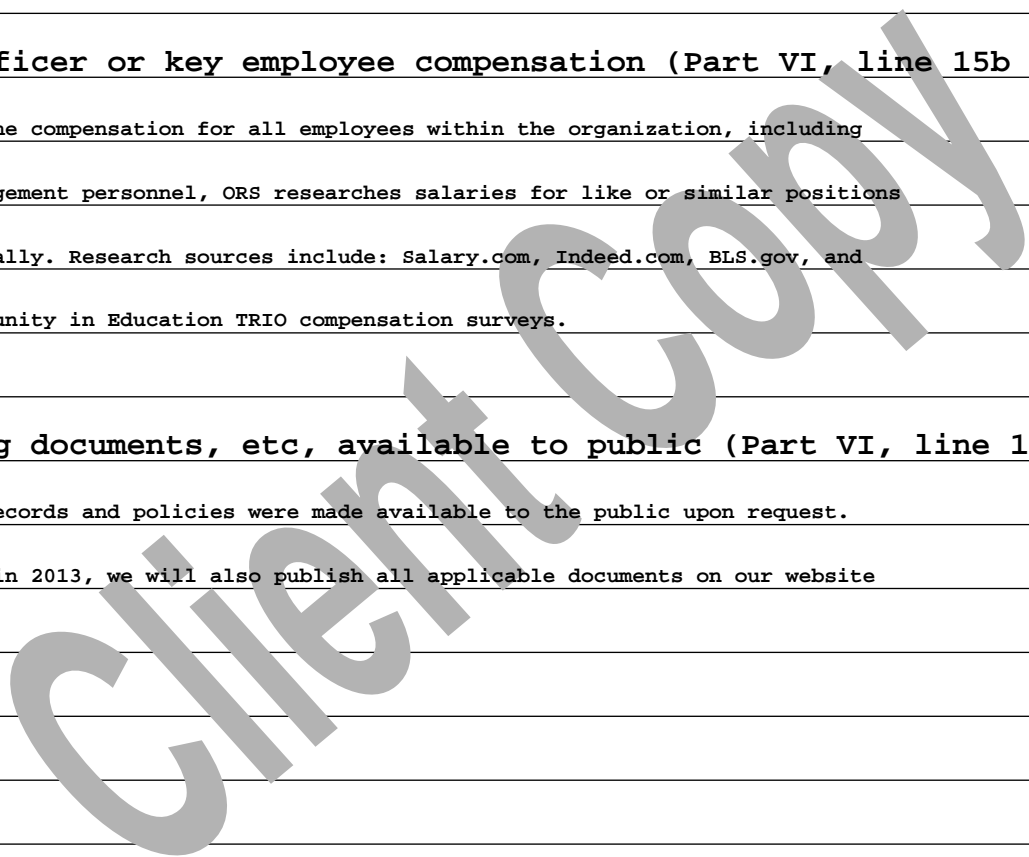
