In 2013, we continued the Upward Bound program at the target schools, recruited and served the required amount of students, hired tutorial staff, provided daily tutorials for students after school, facilitated a six-week intensive summer program, hosted multiple workshops, and organized multiple field trips to colleges and culturally enriching sites.

Upward Bound Math & Science is a federal grant program funded by the Department of Education designed to strengthen the math and science skills of participating students.
